What is Masonic Amity?

The word "Amity" is defined in the Oxford Dictionary as *friendly relations* and in the Webster Dictionary as *friendly relations between nations*. The "Tweetalige Woordeboek" has "vriendskaplikheid". In Masonic terms, it means: acceptance for an active relationship. Amity is an interesting subject and this article is a summary of the lecture which I will present at the 18th World Conference of Grand Lodges in Israel during May 2023 and which was initially compiled and presented by MW Bro Geoffrey Edwards OSM to a number of Lodges, both locally and internationally.

There are a large number of Grand Lodges in the World with sizes ranging from approximately 200,000 members in more than 6,500 Lodges to Grand Lodges with less than 100 members in only 3 or 4 Lodges. Before considering the question of Amity however, it is important to first determine what a Grand Lodge is. The internet defines a Masonic Grand Lodge or Grand Orient as the governing body that supervises and governs the individual Lodges of Freemasons in any particular geographical area or jurisdiction, which usually corresponds with a national boundary or other political unit. While this definition explains where a Grand Lodge's physical boundaries may be located, it does not tell us what makes a Grand Lodge Masonic and it could also apply to any international or regional organisation, which usually has a regional and / or international controlling body. Each Masonic Grand Lodge is totally independent. There is no central body to which they can or do report and each Grand Lodge makes its own rules and regulations. To determine what makes a Grand Lodge Masonic, we must refer to the defined and accepted Ancient Landmarks.

Percy Jantz stated that the Masonic term "Landmark" was derived from the Book of Proverbs in the VSL, Chapter 22 verse 28. The KJV states: Remove not the ancient landmark which thy fathers have set. The NLT versions states: Do not move the ancient boundary markers set up by previous generations. According to Wikipedia, Masonic Landmarks are a set of principles that Freemasons consider to be the ancient and unchangeable precepts of Freemasonry. Issues regarding the regularity of a Masonic Grand Lodge have been and still are judged in the context of these so-called Landmarks. As each Grand Lodge is self-governing and as different Masonic jurisdictions may choose to adhere to different Landmarks, the interpretations of these precepts or principles can and do vary which could affect the recognition of and the impact on Amity between Grand Lodges. It is important to remember that these Landmarks go back to the very roots of Freemasonry and it seems that the first use of the term "Landmark" was in Payne's "General Regulations", which were published with Anderson's Constitutions in 1718. It appears that all the early Grand Lodges had their own defined Landmarks and upon considering them, we find some intriguing differences.

During the next century, there were various attempts to define the Masonic Landmarks and the number thereof. Renowned Masonic writers like Joseph Newton determined 4; Roscoe Pound - 6; Woodford - 18; Mackey - 25; the Grand Lodge of New York - 31 and the Grand Lodge of Kentucky - 54. All saw their list as complete and correct, even if such Landmarks as Fellowcrafts are required to attend church every Sunday, appeared amongst them. Mackey's list, included the Landmark that the Grand Master has the right to make a Freemason on sight. When Nelson Mandela passed away, a press article stated that he had been a Freemason. The Mandela family denied it and as the South African Freemasons were not aware of him ever being initiated in any Masonic Lodge, it was accepted to be fake news. We subsequently discovered, however, that Mr Mandela had been made "a Freemason on sight" by the Prince Hall Grand Lodge of North Carolina. In terms of their Landmarks, they did not need him to progress through the 3 Craft degrees and we have often wondered how we would have reacted if this iconic Statesman had approached us for recognition as a Freemason.

Despite several inconsistencies, the lists of Landmarks also had much in common, for example: a belief in a Supreme Being / the belief in the immortality of the soul / a "book of sacred law" as an indispensable part of the "furniture" of the Lodge / the legend of the Third Degree / the modes of recognition /

the symbolic ritual of the Lodge and, that a Freemason must be a male person, who is freeborn and of a lawful age. In 1929 the United Grand Lodge of England introduced their "Conditions for Recognition of Grand Lodges" which comprised the following conditions: the regularity of origin, i.e. that each Grand Lodge shall have been established lawfully by a duly recognised Grand Lodge or by three or more regularly constituted Lodges / a belief in the GAOTU and His revealed will, being the VSL, shall be an essential qualification for membership / all initiates shall take their obligation on or in full view of the open VSL by

which is meant that the revelation from above is binding on the conscience of the particular individual who is to be initiated / the membership of the Grand Lodge and individual Lodges shall be composed exclusively of men / each Grand Lodge shall have no masonic intercourse of any kind with mixed Lodges or bodies which admit women as members / the Grand Lodge shall have sovereign jurisdiction over the Lodges under its control / the Grand Lodge shall be a responsible, independent governing organisation with sole and undisputed authority over the Craft Symbolic Degrees being the Entered Apprentice, the Fellowcraft and the Master Mason within its Jurisdiction / the Grand Lodge shall not be subjected to or divided in authority with a Supreme Council or any other Power claiming any control or supervision over the 3 Craft degrees / the 3 Great Lights of Freemasonry being the VSL, the Square and the Compasses shall always be exhibited when the Grand Lodge or its subordinate Lodges are at work / the discussion of religion and politics within the Lodge shall be strictly prohibited / the principles of the Ancient Landmarks, customs and usages of the Craft shall be strictly observed.

These conditions are still the basic internationally accepted criteria and most Grand Lodges approaching us for recognition will state whether they have been recognised by the UGLE. While our Grand Lodge is recognised by and is in Amity with more than 150 Grand Lodges throughout the World and while it has certain additional local Landmarks as set out in the preamble to its Constitution, it strictly adheres to these Conditions of Recognition. Should any Grand Lodge or any members thereof decide that it or they will reject or ignore these generally accepted Landmarks, then that Grand Lodge runs the risk of losing its recognition and being out of Amity with the main stream of Grand Lodges, which will then preclude any interaction between it and most other Grand Lodges. Masonic Amity is therefore a very serious matter and every Freemason should be fully familiar with the Landmarks of his own Grand Lodge as well as the internationally accepted recognition criteria as Amity offers the extraordinary benefits of being a Freemason. Amity is very important to Freemasons throughout the World and is the envy of many other international organisations which do not subscribe to these basic principles and consequently do not enjoy international fraternal relationships such as those we Freemasons do.
