Masonic Obligations and their Meaning

In every degree we progress through and in every office to which we are elected or appointed in our Lodges, in our Provincial Grand Lodges and in Grand Lodge we are requested to take an obligation on the Volume of the Sacred Law and in the presence of our fellow brethren. While these obligations may differ in content and length, there is a common thread in every Masonic obligation in which we promise to fulfil certain duties. None of these duties are in conflict with those which we owe to the Great Architect of the Universe, to the laws of our Country or to our families and fellow men. In the Apprentice Degree we promise, for example, to observe the golden rule to "do unto others as we would have them do unto us"; to obey the Brethren to whom the management of the Lodge has been entrusted as well as the Constitution, Laws and Regulations of the Grand Lodge. When a member is elected as Presiding Master of his Lodge he must, for example, promise to maintain and uphold the dignity of his Lodge and to watch over its glory, welfare and prosperity. This is similar to the obligations taken by a Provincial Grand Master on accepting the appointment to this office and by the Grand Master on being elected to the highest office in any Grand Lodge.

What do these promises or obligations mean? In this context, a promise is defined as a declaration or assurance that a person will do something. It is that person's word of honour, pledge, vow or guarantee and the persons to whom the promise is made can expect the person making the promise to do what he is promising to do. As far back as 1722 it was accepted that a Lodge is not a building or a place but rather an assemblage of Freemasons who possess a Volume of the Sacred Law, a square, a compass and a Charter or Warrant of Constitution which empowers them to perform the work which is described therein. In other words, a Lodge is the members of the group which is now called by a specific name, for example Lodge X. The member of this group who is elected as the Presiding Master promises to maintain and uphold the dignity of each and every member of this group and to watch over each and every member's glory, welfare and prosperity. This is a very onerous obligation.

Masonic obligations are therefore central to the principles and values of Freemasonry and are the foundation of Masonic teaching. They are an essential part of every ceremony where a member is requested to promise to fulfil any duty and must be taken seriously. The principles of Freemasonry remind every member to live a life of integrity, to practice high moral standards and to be of service to all persons. Masonic obligations encourage members to be dedicated to Freemasonry and to the members of the community in which they live and work. These obligations are therefore not only essential to the fraternity of Freemasons but are also significant to society.

William Preston, a renowned Freemason, stated that union is cemented by sincere attachment in the Lodge and pleasure is reciprocally communicated in the cheerful observances of every office. Tools and implements of architecture have been selected to imprint serious truths on our memory and so the principles and tenets of Freemasonry have been transmitted by its members through the ages. Albert Mackey, the author of Jurisprudence of Freemasonry, stated that there are no secrets to Masonic obligations and more injury has been done to Freemasonry by needless reserve than by liberal publication of its principles and values. By complying strictly with our Masonic obligations we will therefore continue to build a multi-cultural brotherhood of good men who practice brotherly love and benevolence and who are united in the enhancement of truth, wisdom, high moral standards, equality and justice and who are committed to making the World a better place for all persons.
